

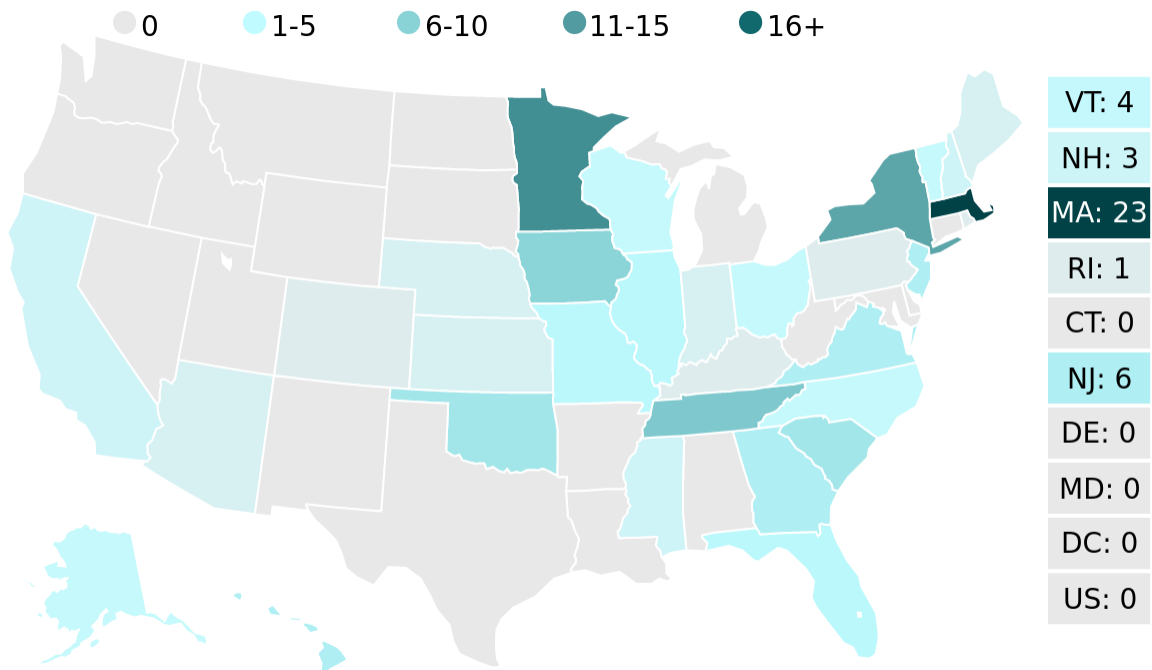

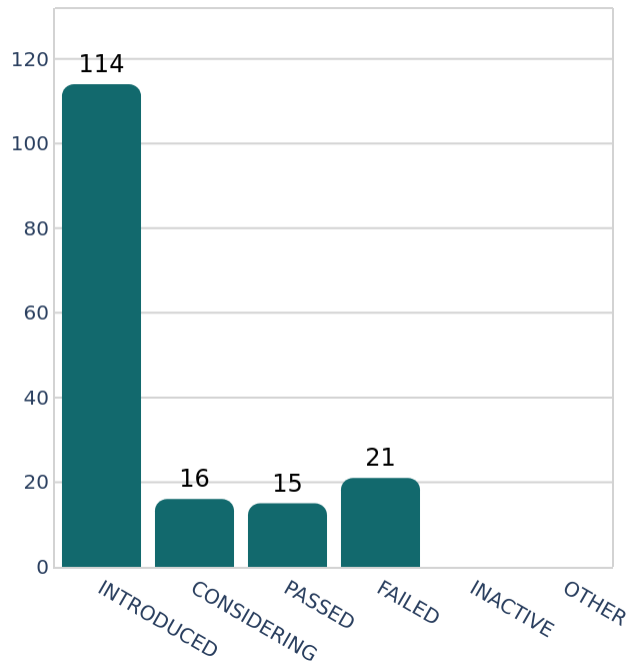
## Policy Map

Policies in your Projects by state



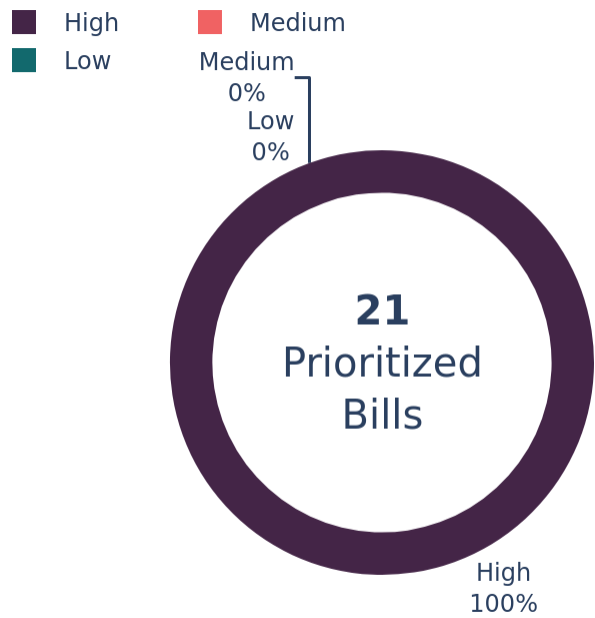
