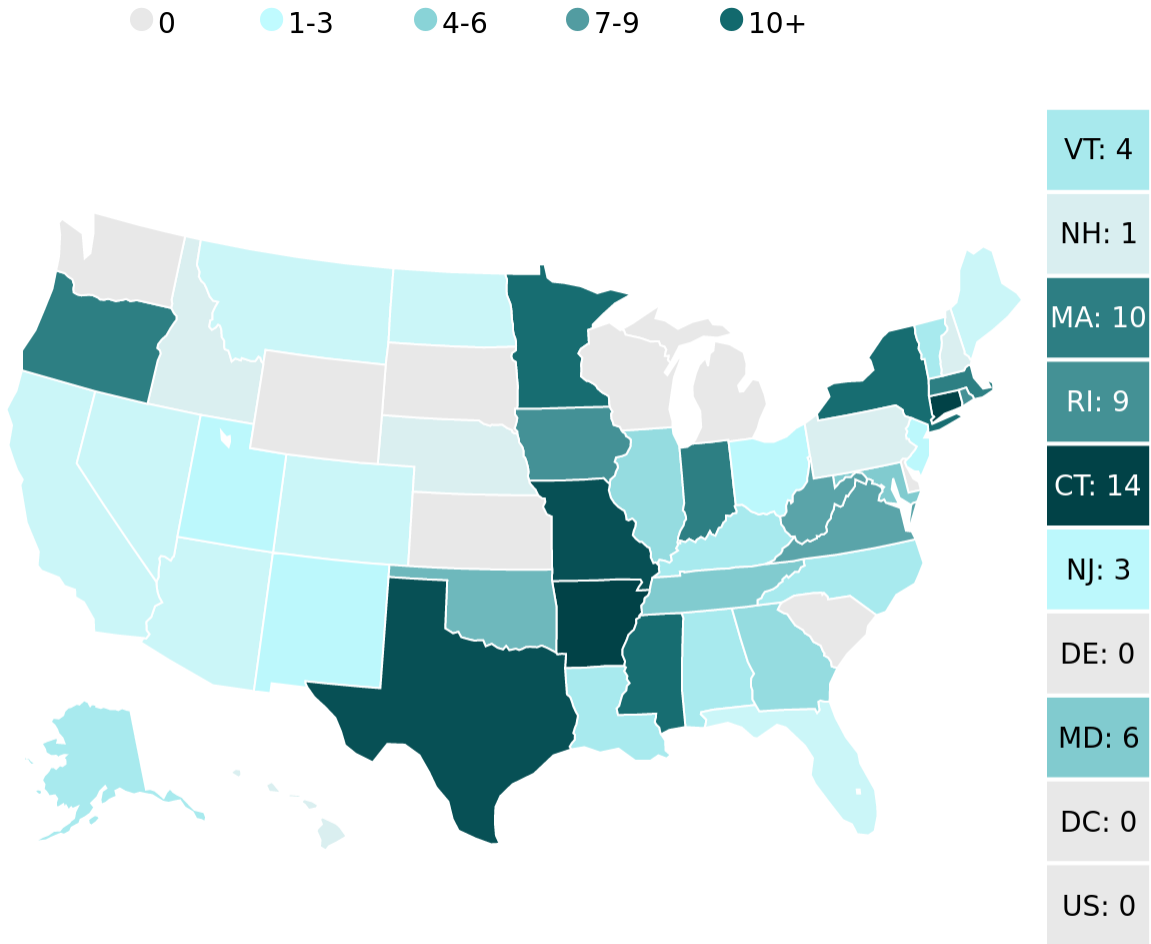

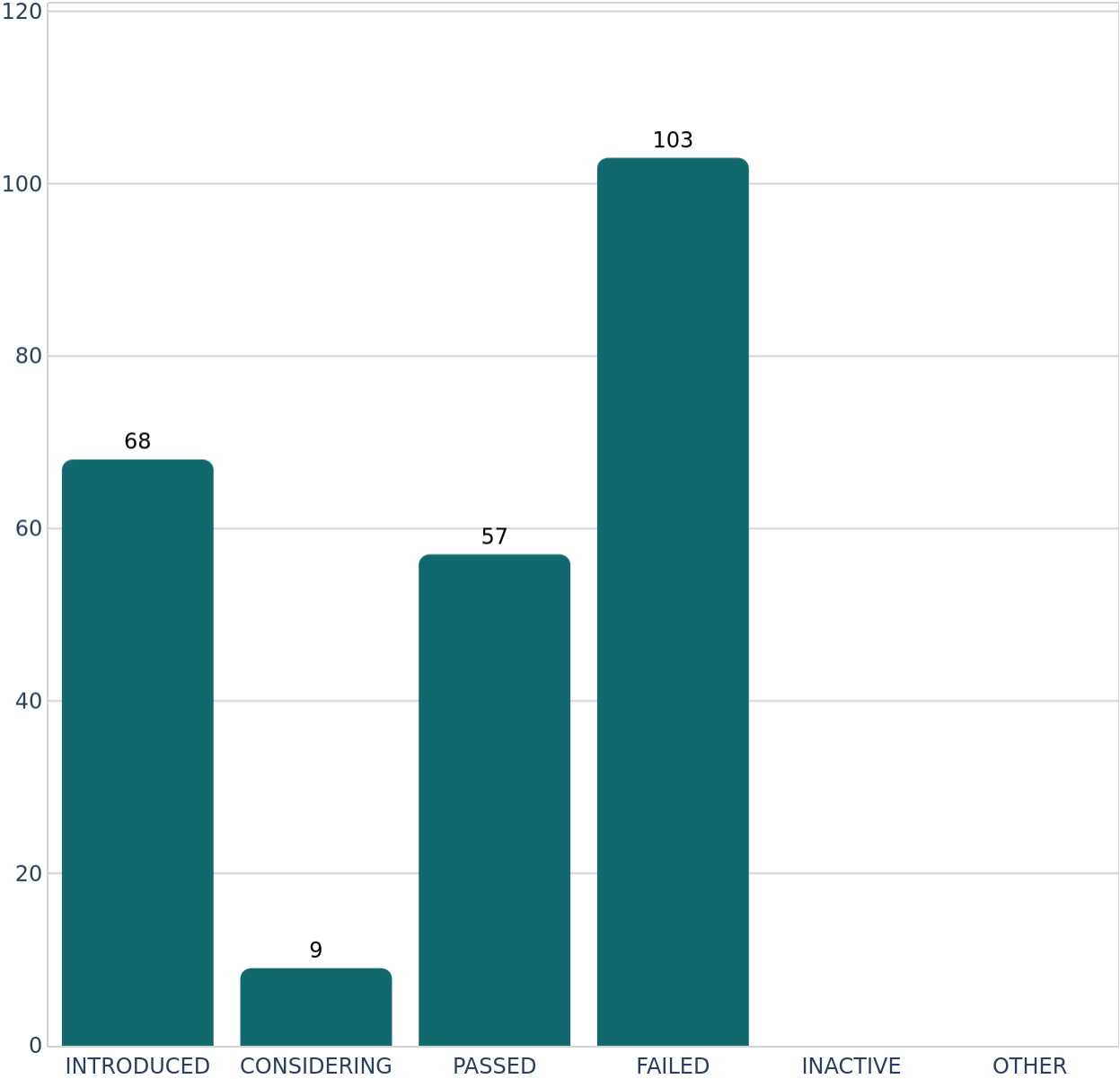
# Policy Map
